Full Contest Details

Official Rules and Regulations

Eligibility

1. All participants must produce a two-dimensional body of work and may consist of various materials, including but not limited to: painting, drawing, mixed media, photograph and textiles. All artwork must be exhibit-ready: stretched, framed, mounted etc.
2. To be eligible for judging, all artists must submit a maximum of six (6) digital images of their original artwork, which shows the presence of a consistent theme. The theme you choose to present will be the theme displayed in the Dream Home.

The contest submission deadline is **11:59 pm on Monday, February 28th, 2022.**

Winner Will Receive

- Their art collection displayed in the Dream Home for the duration of the 2022 Calgary Stampede.
- Homes by Avi sponsored 'Artist Winner Reveal' event, hosted at Gibson Fine art Gallery. *Pending Alberta COVID-19 restrictions.*
- 1 art piece to be displayed at the 2022 Calgary Stampede's Western Showcase art show.

Selection Process

3. Artwork that copies, reproduces, imitates or otherwise infringes on any copyrighted material will not be considered. When producing portraits of real persons, artists must have a model release or consent forms signed by their subjects that grant the artist permission to use their likeness and display, exhibit or otherwise circulate.

Undertakings and Warranties

4. **The Artist must produce or supply 30-40 paintings in various sizes within their chosen theme two (2) weeks before the start of the 2022 Calgary Stampede.**

The official deadline will be confirmed and agreed upon with the chosen Artist and Homes by Avi interior designers.

5. Artwork will be required to be on display until the end of the last day of the 2022 Calgary Stampede. The Artist will be required to have their art picked up from the Dream Home on a day agreed upon by the Artist and Homes by Avi after the Calgary Stampede.

6. Homes by Avi agrees to use its best efforts to promote the Artist's work prior to and during the duration of the 2022 Calgary Stampede.

7. The Artist warrants that the artwork submitted is the Artist's original work and that the Artist holds the copyright.

8. Homes by Avi shall be solely responsible at its discretion for hanging the art and preparing promotional material for the Dream Home.

9. The Artist will be responsible for all shipping, materials, framing and insurance costs, and fees incurred for transporting the Artist's art to and from the Dream Home.

10. The Artist grants permission to Homes by Avi and Swerve to use slides of the submitted material for the purpose of publicity and promotion on Homes by Avi's and Swerve's websites and in print collateral pertaining to this contest and the Dream Home.

11. The Artist shall not remove any art for any reason items from the Dream Home until the day immediately following the final day of the Calgary Stampede.

Sales and Commissions

12. In the event a painting should sell during the time it is displayed in the Dream Home, Homes by Avi agrees to take no commission, and all profits will be that of the Artist.
